

# Memorandum of Understanding



This Memorandum of Understanding ("MoU") is signed on the 2th day of November 2018 BY AND BETWEEN:

## MGSM's Arts, Science and Commerce College, Chopda, Dist. Jalgaon

(An institute which runs UG & PG courses in Arts, Science and Commerce faculties and affiliated to Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon; hereinafter referred to as "ASC College")

#### AND

#### **ME CALL SERVICES**

("An organization which provides services for electronics circuits, development of SMPS, power supply, electronics trainer kits. Plot no. 28, MIDC Flatted Building, Satpur, Nashik-422007 (Maharashtra) India")

This Memorandum of Understanding is proposed in order to bridge the gap between the academia and industries. The MoU aims at skills development by providing various trainings to the students and faculty members of MGSM's Arts, Science and Commerce College, Chopda, Dist. Jalgaon

Through this Memorandum of Understanding, the two parties agree to the following:

A steering committee will be set up to monitor the activities of the MoU. The committee will consist of Satish Suryawanshi (Director, ME CALL SERVICES, Satpur, Nashik), Dr. D. A. Suryawanshi (Principal, MGSM's Arts, Science and Commerce College, Chopda, Dist. Jalgaon) and Prof. Dr. A. L. Chaudhari (Vice Principal and HoD (Electronics), MGSM's Arts, Science and Commerce College, Chopda, Dist. Jalgaon).

- (a) With mutual consent, the steering committee can be expanded to include more members from the two institutions. The steering committee will be the supreme body as far the implementation of the activities of the MoU, the continuation of the MoU, and termination of the MoU are concerned.
- (b) ASC College and ME CALL SERVICES will jointly conduct short-term training programs &workshops in following areas:
  - i. Industrial Training
  - ii. Industrial Visit
  - iii. Sharing the Knowledge and Resources
  - iv. Workshop and Training programs
  - v. Any other training areas, as may be deemed fit for both the parties.
- (c) ASC College will organize training programs for its students and faculties, on the above-mentioned areas and ME CALL SERVICES will conduct / co-ordinate these trainings.
- (d) ASC College and ME CALL SERVICES will jointly conduct the workshop and training program for the students. The objective of this activity is to give the industrial Page 1 of 2

training and develop necessary skills among the students in the field of Electronics which will built their confidence and overall impact during the interview.

- (e) ASC College will provide all necessary infrastructure such as training hall, projector, PA system, computer lab, etc. as will be required for training workshops and assessment from time to time.
- (f) ME CALL SERVICES will provide all necessary training material as applicable, which will be mentioned in the training and assessment proposals submitted with ASC College from time to time.
- (g) Expert lectures / Workshops / Events: If ASC College wishes to organize lecture series / national events, ME CALL SERVICES will assist in providing speakers.
- (h) Industrial Visits: ME CALL SERVICES will assist ASC College in arranging industrial visits of its final year students.
- (i) Validity: This MoU is valid for a term of three years from the date of signing, unless terminated earlier or extended by mutual agreement of both the parties at latest thirty days prior to the expiry.

### (j) Miscellaneous:

- All conditions, changes, erasures, amendments, waivers, etc. shall only be in writing, duly executed by both the parties.
- This MoU and any amendment thereof are limited to the purpose of MoU only.
- This MoU sets forth the entire agreement and understanding between the parties with respect to the subject matter hereof and merges all discussions and negotiations between them, prior to such execution.
- This MoU shall be governed by the laws of Republic of India.
